

Our tasks begin with road safety and include research and analytic work, preventive and educational programmes, expert tasks related to the national road safety programme, tasks related to drivers and vehicles.












ROAD SAFETY SITUATION IN SLOVENIA – ALCOHOL RELATED ROAD ACCIDENTS


National program of road safety for the period 2013 - 2022

TO REDUCE BY 50% THE NUMBER OF TRAFFIC ACCIDENTS WHERE THE SECONDARY FACTOR IS ALCOHOL, ILLICIT DRUGS OR OTHER PSYCHOACTIVE SUBSTANCES OR NOT MORE THAN 17 FATALITIES IN 2022

 \rightarrow from 16% to 4%





ROAD SAFETY SITUATION IN SLOVENIA – NUMBER OF TRAFFIC OFFENCES DUE TO DRINK DRIVING






ROAD SAFETY SITUATION IN SLOVENIA – YOUNG ROAD USERS AND ALCOHOL



Validity of drivers license of causers of road accidents (with fatalities and severe injuries) (18-24 years of age)





□ In 1947, we reduced the level of alcohol in Slovenia to 1.0 g/kg (‰)

□ In 1950 the limit was reduced to 0.5 g/kg (‰)

□ In 1965 we introduced a complete ban for professional drivers - 0.0

g/kg (‰)

□ Since 2005, we have 11 groups of road users, who have a total ban

on alcohol





Restrictions on the use of alcohol (alcohol policy) \rightarrow **PROHIBITIONS**:

- The sale and supply of alcoholic beverages to persons under the age of 18.
- To sell alcoholic beverages to persons showing obvious signs of alcohol abuse.
- To sell alcoholic beverages from automatic self-service devices.
- To sell alcoholic beverages between 9 pm and 7 am on the following day, except in catering establishments (bars, pubs, restaurants...) with a permit.

STRICTER SANCTIONS (Act of Traffic Rules; Article 105; stricter penalties for drink driving in 2008 and 2010):

Participant's attitudes and excuses:

- Preventive activities and media campaigns with clear message that alcohol in unacceptable in traffic
 - Preventive events
 - Expert conferences
 - Round tables



- Implementation of educational and preventive programs in primary schools and in high schools
- Police enforcement (breath alcohol testing)
- Informing public about medical examinations and rehabilitation programs
- Records of repeated traffic offenders

PUBLIC OPINION ON ALCOHOL IN TRAFFIC


Time of study: May 2017 Number of respondents: 1.500

The biggest problems for the respondents are:

- Drivers under influence of alcohol (rating 4,64)
- Drivers under influence of illicit drugs and other psyhoactive substances (rating 4,61)
- Using mobile phones while driving (rating 4,55)

Respondents generally support proposed measures:

- 52% of respondents supports the measure that legal limit of alcohol is reduced to 0.0 g/kg
- 80,5% of respondents supports the installation of alcolocks for the drivers who were driving under the influence of alcohol
- 90,1% of respondents support the installation of alcolocks for the professional drivers

• NEW!! National preventive campaing ALCOHOL, DRUGS and PSYHOACTIVE SUBSTANCES

STUDY (2016): Driving under influence of illicit drugs in Slovenia

- As many as 8% of the respondents have been already behind the wheel under the influence of drugs. Every third one does it regularly!
- Most common drugs among Slovenian drivers are: marijuana, cocain and amphetamines.
- There were two times more refusals of medical exams in case of traffic offence (in 2017 compared to 2016).
- Drugs are completely unacceptable in traffic, as they have a strong impact on driving skills. Like alcohol, drugs also affect perception, anticipation, judgment, and deciding and finally implementing appropriate behavior.
- Consequences on Slovenian roads due to drug-related driving in 2017:

5 fatalities, 23 severely injured, 50 slightly injured

WHAT WE PLAN TO DO

In the next years

Amendment of the legislation:

- 1. Rules on Educational and Psychosocial Workshops
- 2. Rules on medical examinations

Renovation of rehabilitation programs::

- 1. Extension of educational workshops for 8 hours (2x 4 hours)
- 2. Measures for repeat traffic offenders (interlock?)
- 3. Different programs for drug addicts
- ✓ **Evaluation of rehabilitation programs** → evaluation among participants of rehabilitation programs
- Police enforcement (focused on drivers under influence of alcohol and illicit drugs),

Preventive campaigns:

- Media awareness campaigns
- 2. Preventive events
 - Workshops in highschools
