




Introduction

Slovenia:


- independent country since 25 June 1991,
- 20,273 km2 area,
- junction of different geographic regions: the Alps, Pannonian Plain, Dinaric – Karst Area and the Mediterranean,
- population a little over 2. mio.





Introduction

- Administration of the Republic of Slovenia for Civil Protection and Disaster Relief (Ministry of Defence):
- Specific expert tasks related to protection against natural and other disasters
- Act on Protection Against Natural and Other Disasters (Official Gazette of the Republic of Slovenia, 97/10)
- Fire Protection Act (Official Gazette of the Republic of Slovenia, 113/05)
- Fire Service Act (Official Gazette of the Republic of Slovenia, 83/12)





Volountary


- 1.314 voluntary fire units,
- 37.257 operational voluntary fire-fighters,

Professional

- nearly 600 professional fire-fighters in 14 brigades,
- around 300 professional fire-fighters in industry,
- Fire service = local service
- Each municipality has a local unit




 Since 1993 – government cofunding some local fire fighting units for the tasks that exceed local domain (GEŠP units)





GEŠP units:

- water rescue,
- rescue in case of accidents with dangerous substances,
- rescue in longer road tunnels (longer than 500/1000 meters),
- rescue in longer railway tunnels (longer than 1000 meters) and
- technical rescue in traffic accidents on state roads.



<u>Time coverage analysis in 2014</u>


• Starting point:

- max 20 minutes time for the unit to get to the place of the accident,
- If time is between 20-30 minutes activation of two neighbouring GEŠP units on the area at the same time,
- time larger than 30 minutes is unacceptable – cases solved individually
- optimising only the state roads coverage
- Analysing interventions from 2010 to 2014

Results:






Driving time to the local GEŠP unit









Driving time to the nearest GEŠP unit:









- Rationalization of interventions in road accidents
- possible activation of GEŠP unit and the local unit – if specified in the local activation plan and if the criteria is fulfilled
- Criteria:
 - Driving distance between GEŠP unit and local unit must be at least 15 minutes,
 - local unit must have at least 4 firemen, qualified for technical rescue,
 - local unit must have a suitable vehicle for technical rescue.



Conclusions

- Added 5 new temporary GEŠP units that in total now results in 56 GEŠP units (45 for technical rescue in traffic accidents, 15 professional, 40 volountary units).
- After 2 years (in 2018) new analysis.
- The territory is adequately covered
