ABOUT THIS YEAR'S THEME

In the EU as a whole, 1% to 2% of journeys are associated with an illegal Blood Alcohol Limit. Drink driving remains an important contributory factor in 1 out of 3 road traffic crashes, with at least 6,500 deaths on EU roads annually. This year's lecture will discuss the risks related to alcohol and driving as well as effective countermeasures in the fight against drink driving in Europe.



Professor Richard Allsop is Emeritus Professor of Transport Studies at University College London, having been a Professor since 1976 in what is now the Centre for Transport Studies. After graduating in Mathematics from Cambridge, he joined the Road Research Laboratory, where his first main task in 1964 was to interpret for Britain the results of the US Grand Rapids study of alcohol and collision involvement – a topic in which he has been active ever since. He has contributed widely to transport research, training and advisory work, including safety research and its application, with leading roles in PACTS and ETSC over the last two decades. He was honoured by the Queen in 1997 for services to traffic management and road safety, and is a Fellow of the Royal Academy of Engineering in Britain and an Honorary Professor in Krakow and in Moscow.

SMART (Sober Mobility Across Road Transport) is a three year project addressing the main issues related to alcohol and driving and continue ETSC advocacy activities both at EU and Member States level to tackle drink driving and reduce the number of alcohol-related deaths. The activities within SMART are consistent with and supplement ETSC's systemic and evidence-based approach to road safety work.
